

Mr. Christopher Glover was appointed as the Chairman, Army Clemency and Parole Board on 1 March 2020. In this capacity, he is responsible for the oversight and conduct of Army Clemency and Parole Board hearings for all Soldiers confined in military facilities, as well as those transferred to the Federal Bureau of Prisons for incarceration. He also oversees hearings for former Soldiers on parole or mandatory supervised release. He is also responsible for monitoring the behavior of all former Soldiers under supervision by U.S. Probation Officers. The Army Clemency and Parole Board conducts over 1000 clemency and parole board hearings annually.

Mr. Glover served six years as an enlisted Soldier in the National Guard before earning the distinction of Distinguished Military Graduate (Army ROTC) from Grambling State University, and a Regular Army commissioning in 1995. He holds a Bachelor of Science in Business Marketing from Grambling State University, a Master of Arts in Business & Organizational Security Management from Webster University, and a Master of Military Operational Art and Science from Air University. Prior to retiring in 2015, Mr. Glover's deployed and led Soldiers in support of military operations in Bosnia, Kosovo, the Military District of Washington, Afghanistan, and Korea. Prior to his assignment as the Chairman of the Army Clemency and Parole Board, Mr. Glover served 5 years as the Chief of Operations for the Army Corrections Command.
